APPLICATION FOR ACCREDITATION TO OFFER A QUALIFICATION REGISTERED ON THE GENERAL AND FURTHER **EDUCATION** AND TRAINING SUB-FRAMEWORK OF **QUALIFICATIONS**

1. Thank you for your application for accreditation to offer the following subjects of the General Education and Training Certificate: Adult Basic Education and Training (GETC: ABET) at NQF Level 1.

- 2. Accreditation attests to the capacity of a private college to offer a qualification registered on the General and Further Education and Training Qualifications Sub-Framework (GFETQSF), at the required standard.
- 3. Having carefully considered your application for accreditation, Umalusi Council herewith grants Triple-E Training, CIPC Number: 2002/006151/07 of 277 Jorissen Street, Monument Park, Krugersdorp, 1733, provisional accreditation for a period of two years to offer the General Education and Training Certificate: Adult Basic Education and Training (GETC: ABET) Level 4 at NQF Level 1. The provisional accreditation period commences on 15 June 2021 and terminates on 31 December 2023. Accreditation number: 13 AET03 00004 PA.

- 4. The decision of Council was informed by the following:
 - 4.1 Legislation and policy:
 - 4.1.1 The National Qualifications Framework Act, 2008: The Act provides for the establishment of Umalusi as a Quality Council (QC) for General and Further Education and Training.
 - 4.1.2 The General and Further Education and Training Quality Assurance Act, 2001 amended 2008: This is the founding Act of Umalusi that outlines Umalusi's specific mandate.
 - 4.1.3 Policy for the Quality Assurance of Private Colleges for Continuing Education and Training, offering Qualifications registered on the General and Further Education and Training Qualifications Sub-framework, and the Accreditation of Private Assessment Bodies. (Government Gazette 41887 notice 926 of 7 September 2018).
 - 4.1.4 Guidelines for Implementation of the Policy for the quality assurance of private colleges for Continuing Education and Training offering qualifications registered on the General and Further Education and Training Qualifications Sub-framework GFETQSF (2020).
 - 4.2 Reports:
 - 4.2.1 The provider's self-evaluation report;
 - 4.2.2 The desktop evaluation of the self-evaluation report;
 - 4.2.3 The verification site visit report.
- 5. The attached "Feedback on Accreditation Application" indicates the areas where the college must still demonstrate compliance. Note that during the provisional accreditation period, the college is expected to meet the minimum requirements in **all** the accreditation criteria.
- 6. The fee for re-evaluation of the application must be paid by 31 May 2022, and the college must meet the minimum requirements for accreditation by the same date (31 May 2022). Upon receipt of the required fee by the specified date, Umalusi will conduct an unannounced site visit to evaluate the institution's compliance with all the minimum requirements for accreditation (not only those indicated in the feedback report).
- 7. Please note that no further evidence will be considered after the verification site visit. The balance of the provisional accreditation period is to allow for finalisation of the outcome, and to allow for the completion of the academic cycle.
- 8. The provisional accreditation of **Triple-E Training** is subject to the following conditions:
 - 8.1 For the duration of the provisional accreditation period, the institution must continue to provide tuition for the General Education and Training Certificate: Adult Basic Education and Training (GETC: ABET) Level 4 at NQF level 1.

- 8.2 The provisional accreditation will be withdrawn with immediate effect if the institution is:
 - 8.2.1 implicated in serious assessment and examination irregularities/malpractices.
 - 8.2.2 offering subjects/programmes not stated on this letter.
- 8.3 The provisional accreditation pertains solely to Triple-E Training and may not be used by any other agent or company. The provisional accreditation for Triple-E Training is not transferable to any other agent or institution. Only the bearer of this letter may use the accreditation.
- 9. The provisional accreditation will be withdrawn with immediate effect if the college is implicated in serious assessment and/ or examination irregularities/malpractices.
- 10. Failure to pay the required fee within the specified time will result in the Accreditation Committee of Council making a final recommendation based on the initial evaluation. (No further engagement on the application will be considered).
- 11. Umalusi may conduct a special / additional site visit in the event of the following:
 - 11.1 A valid complaint by the learner/s, parent/s, official/s from the Department of Higher Education and Training or the public.
 - 11.2 A significant drop in the learner performance of the institution.
 - 11.3 A change in the ownership of the institution.
 - 11.4 Any significant change in the institution's staff establishment.
 - 11.5 Failure to comply with health and safety standards, as per the Occupational Health and Safety Act.
- 12. Should the institution move to new premises and facilities or change ownership, it is required to notify Umalusi within 14 days.
- 13. A change of the principal necessitates the submission of the new principal's details (Certified copies of Identity Document, teaching qualifications and current registration with the South African Council for Educators) to Umalusi within 14 days.
- 14. The GENFETQA Act No. 58 of 2001 as amended in 2008, requires private institutions offering qualifications registered on the General and Further Education and Training Qualifications Sub-framework to be accredited by Umalusi. It also requires Umalusi to report accreditation decisions to the Registrar in the Department of Higher Education and Training. At the expiry of the two-year provisional accreditation Umalusi will report the final outcome to the Department of Higher Education and Training. Your institution is therefore urged to comply with the areas needing attention within the specified timelines.

15. On receipt of this letter the institution may publicly promote its provisional accreditation status. However, the institution is restricted to the following wording:

"Provisionally accredited by Umalusi, Council of Quality Assurance in General and Further Education and Training – Accreditation number: 13 AET03 00004 PA."
